- No Word or Publisher files

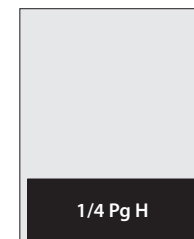
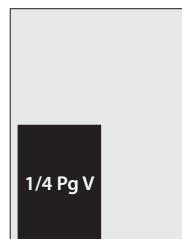
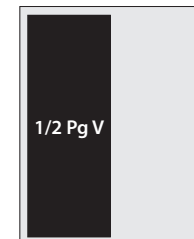
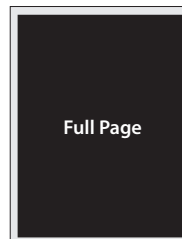
Resolution
